Dr. Tampakoudis holds a BSc and a PhD in Finance from the University of Macedonia, and he obtained an MSc in Banking and International Finance from the Business School of City University, London. In his academic role, he instructs courses at both the undergraduate and postgraduate levels, covering subjects such as corporate finance, capital markets, international finance, and entrepreneurship. His research has been featured in peer-reviewed academic journals, including the Journal of Financial Stability, European Management Journal, International Journal of Finance and Economics, Business Strategy and the Environment, Research in International Business and Finance, and Corporate Governance: The International Journal of Business in Society. Dr. Tampakoudis has actively participated in over 40 international academic conferences and has been honored with the "Best Paper" award three times. He currently holds the position of Scientific Coordinator for a research project funded by the Hellenic Foundation for Research & Innovation (Project Number: 5098), as well as a research project supported by the University of Macedonia. Previously, he served as the Scientific Coordinator for an INTERREG program (Greece-Republic of North Macedonia 2014-2020) and as the Deputy Scientific Coordinator for another INTERREG program (Greece-Bulgaria 2014-2020).
