He has been serving, among other duties, as the first Director of the newly established Sub-Division of Cybercrime of Northern Greece (2015), and thereafter (2016-2018) as Director of the Cybercrime Division of the Hellenic Police Headquarters.

He is

He is a qualified **Forensic Document Examiner**, being simultaneously the first Head of the QDE Forensic Lab in Northern Greece.

He has been a regular member of the European Cybercrime Task Force (EUCTF) of the European Cybercrime Center (EC3) of Europol (2016-2018).

He is also Honorary member of the Panhellenic Scientific Association of Health Informatics (P.E.E.PL.Y.) and member of the team of the Institute for Action against Drug - PADA.
